Reiwa 6/FY 2024 Financial Assistance for Municipal School Students (Shugaku Enjo)

Those who had this financial assistance last year also need to apply annually as needed.

The Board of Education of Okayama City bears part of the expenses necessary for school attendance for those who have trouble in enrolling their children in municipal elementary or junior high schools for financial reasons. Please follow the contents below and apply if you are eligible.

Cases for Eligibility

You need to be certified as having equivalent difficulties to those who on public assistance by the Board of Education.

Examples) Household Income you received last year was lower than a certain amount (Please refer to the chart below.), you currently receive Child Rearing Allowance, or the income dramatically dropped this year because of various family reasons such as guardians' death, diseases, divorce or resignation.

«Eligibility Standard by Income»

The total annual household income of the family that the eligible child belongs to should be lower than a certain amount shown below. (It's determined depending on the number of household when applying.)

Please apply online or by mail. (We do not take applications at the counter.)

By mail ⇒ Send the application form with other documents needed to the address shown below.

Documents Required

- Required for all applicants
 - Application Form (Not required when applying online)
 - A copy of the guardian's bank book (The page showing the account number) (When applying online, please attach the photo.)
- Required for only applicable persons (In addition to the documents shown above)
 - Those who have the following certificates and handbooks. (Please send the application form first if the attached documents cannot be ready in time.)
 - ⇒ A copy of Child Rearing Allowance Recipient Certificate (Jido-fuyo-teate-jukyusha-sho)
 - Disability Certificate (Shogaisha-techo)
 - Mental Disability Certificate (Seishin-shogaisha-hoken-fukushi-techo) or
 - Intellectual Disability Certificate (Ryoiku-techo)
 - Those who lived outside Okayama City as of January 1, 2024
 - ⇒ The income certificate (Shotoku-shomei-sho) for the year of 2023 issued by the municipality where you lived at that point.

Notes

- Those on welfare (Seikatsu Hogo) do not need to apply for Financial Assistance for Municipal School Students. Your school will provide you with the information on financial support for School Excursion Expenses.
- Even after you are certified as a beneficiary of this financial support, you are not always exempt for paying school fees. Please be sure to pay them on time. **They could be deducted from the benefits if they remain unpaid.**
- Since school lunch fees are deducted from Financial Support, they are not collected. (*They are collected until you are certified as a beneficiary of the financial support. If you have the school lunch fees overpaid after certified, they will be refunded from Health and Physical Education Division.
- If you become eligible for this financial support after the first term deadline, you may apply in the second (around August) or the third (around December) terms. The schedule for applications will be announced on the Website of Okayama City or its public relations magazines.
- This flyer is available in multiple languages (English, Chinese and Korean). Please contact your school or School Enrollment Division of the city hall if you need one.

•Postage is to be borne by applicants. Please note we are not responsible for nonarrival of the application form.
